Ministries Within Kehilat Shiloh

Kehilat Shiloh is Conservative-styled Messianic Jewish congregation of believers that came together under the Truth within the Scriptures with emphasis on the true meaning, intent, and context of the original source writings of the Torah, the Tanakh, the Apostolic Scriptures, and other Deuterocanonical texts such as the Apocrypha. We teach and preach out of the Torah and the Tanakh from their original Hebrew texts and understanding as well as the Brit Chadashah from their original Aramaic and Greek using the Berean approach of study.

We live and and worship in observation of these Scriptures and the principles within them including:

- *Observation of the Friday evening Erev Shabbat and the Saturday Shabbat services.
- *Observation of the monthly Rosh Chodesh services and sighting of the new moon.
- *Observation of the Feast Holidays of Pesach, Shavuot, Yom Teruah, Yom Kippur, and Sukkot.
- *Observation of the dietary laws such as the prohibitions of pork, shellfish, catfish, and blood.
- *Observation of the tithe and the practice of benevolence to others in need of assistance.
- *Observation of the Great Commission to preach the Good News and to disciple others in Yeshua.
- *Observation within the best of our ability of the Ten Commandments and others in the Scriptures.

In addition to maintaining a benevolence fund as well as the worship services and Scripture studies on Shabbat, Rosh Chodesh, and the Feast Holidays, Kehilat Shiloh also serves as the supervising church ministry of a religious community organization under IRS Code Section 501(d) called Kibbutz Shiloh as part of its ministry service. Members of the kibbutz must first also be members of this Kehilat to qualify for membership under the Federal statutes governing 501(d) religious communities. Please reach out to our leadership for more information concerning this if you have interest in the kibbutz.

Official membership will be conferred upon applicant as well as any and all rights of services and to apply to become part of the ministry leadership including deaconships, congregational leaders, officers, and becoming an Elders. Starting in 2027 a new requirement of contributing at least \$2,500 per annum to the ministry for new membership to be conveyed and membership to be retained has been added due to a recent resolution of our Elder Board. Membership however is not required to attend Shabbat worship services and is open to anyone wishing to regularly visit in worship with us as we believe we are all one extended family under Yeshua in the Kingdom of Adonai.
